Associate Fuel Discount

From October 1 through December 31, 2008, associates can earn 20¢ off per gallon of fuel with each \$100 in qualifying grocery purchase with their Kroger Plus shopper's card. This discount is an additional 10¢ off per gallon savings, on top of our everyday customer fuel discount program. As they do today, associates who use the Kroger 1-2-3 Rewards MasterCard for fuel payment will earn an additional 5¢ off per gallon for fuel. That's a possible savings of 25¢ off per gallon!







This is a brief update on our Can Hunger results, and as of Dec. 22nd, 2008, the Division has raised a total of \$258,661 towards our goal of \$350,000 or 73.9% toward our Division goal.

Did you know?

- Approximately 4.5 million different people receive emergency food assistance from the America's Second Harvest food banks in any given week nationwide.
- 36.4% of the members of households served by Second Harvest are children under 18 years old.
- 8% of the members of households are children 0 to 5 years.
- 10% of the members of households are elderly.
- 42% of families served by Second Harvest have to choose between paying for food and paying for utilities and heating.
- 35% had to choose between paying for food and paying their rent or mortgage.
- \$10 Can Hunger Food Bag provides 10 meals.
- The top 10 stores account for over 20% of the total Can Hunger funds raised.

GET READY FOR TAX SEASON....NOW

As 2008 draws to a close, it's time to think about the unthinkabletax season! April 15 seems far away, but it's important to prepare now. There are several easy things you can do to get ready for tax time-and it only takes the click of a button-ExpressHR. Go to ExpressHR from the kiosk computer in the break room, a computer at work or a computer at home and follow these three simple steps.



Step 1: Verify your address. The company must have your current address in ExpressHR to ensure that

address in ExpressHR to ensure that any tax forms and company information reaches you. Log-in to ExpressHR and click "About My Personal Profile" from the left menu. In the profile screen, you can verify your current address. By clicking the pencil icon next to Address Information, you can update your address, phone numbers and even include a personal e-mail address.

Step 2: Verify your withholdings. ExpressHR allows you to verify and

update your W-4 withholdings. Click "W-4 Change" on the left menu, and the withholdings screen appears. By clicking the Edit button on the screen, you have access to a great feature-an online worksheetthat can help you select your withholdings.

Step 3: Sign up to receive your W-2 online.

From anywhere in ExpressHR, you can click the MyHRInfo icon at the top right of the screen to access MyHRInfo. Select "My Pay" from the menu on the left, and then click "W-2" from the drop-down list. On this screen, you can review



several topics about the W-2, and click the link to The Work Number-a vendor site that manages the company's electronic W-2 forms. (For more information and the specific steps to receive your W-2 electronically, go to BarneyWeb and review the article "Get your W-2 Online.") Your W-2 will be available online by Feb. 1, 2009. Three simple steps and you're ready for tax season! With ExpressHR, you have a one-stop shop for your tax preparation needs.



Dollars for Doers Deadline is December 31

The Foundation reviews applications and mails checks for approved grants directly to eligible charitable organizations. A copy of the letter is also sent to the associate when a grant is mailed. Full- or part-time associates must have at least one year of service to qualify for a grant. Each associate may obtain one Dollars for Doers grant per calendar vear. It's that easy! The next application deadline for Dollars for Doers will be March 31, 2009.
